RM of St. François Xavier Reeve

Reeve for the RM of St. François Xavier, D. Clark spoke on behalf of the requirement of busing within the municipality of St. François Xavier. The Reeve highlighted key points which included the river lot set up within the settlement center, the ownership of roads to Manitoba Infrastructure and not to the municipality, and the poor sidewalk infrastructure. Currently, only one residence and one 8-plex unit have sidewalk access to the St. François Xavier School; all other areas would require crossing highways, busy streets, and/or walking in ditches.
